<p>We collect and hold personal & business information that you provide when you begin the process of applying for relocation. We may also collect information from template forms that we provide (such as the HVR profile document). This includes information provided by you at the time of enquiry, or when you enquire about further services such as our events. We do this in order to facilitate your application, to manage our client relationship with you, and if you consent keep you informed about living in Jersey, Locate Jersey, our services and exclusive events, and where appropriate third party events. It also allows for the anonymised statistical analysis of data so we can plan the provision of future services.</p>	<p>We will endeavour to keep your information accurate and up to date and not keep it for longer than is necessary. We will not share your information with anyone outside of the States of Jersey unless you give us explicit consent to do so. We do not process your information overseas using web services that are hosted outside the European Economic Area.
